### **POOL PRIVILEGES**

Pool staff are onsite and are responsible for ensuring that all pool users have a safe and enjoyable experience. **You must comply with pool staff directions at all times.** Pool staff have the authority to refuse entrance and eject persons for improper behavior or infractions of safety standards. Refusal to follow directions of pool staff may result in the loss of pool privileges for a period of time to be determined by pool manager and/or CCA management.

Pool use is a privilege for members, immediate family, and guests. Pool access privileges are contingent upon all fees and assessments being current. In order to claim privileges as a member, the member's name must be on the roster and the member must have you listed as a user on file. No more than 8 household members per account.

If their name does not appear, they must pay the guest fee and be accompanied by the member until the member adds that family member to their account. Pool use fees for guests are \$4.00 per day per person. Each account will be given 2 free guest passes per week, these will be added at the beginning of the season. No more than 6 guest passes can be used at a time.

A renter and immediate family residing with the renter may use the pool **ONLY** if the pool privileges have been assigned **IN WRITING** by the owner and they are listed on the account from the office. Pool access may not be held by both the owner and the renter.

<u>ALL</u> swimmers must sign in. If a swimmer does not sign in, they are not allowed into the pool. A roster of members authorized to use the pool is provided to the pool staff; if the property owner is not listed as having access to the pool, they will be denied access until permission from the office is issued.

A parent must accompany a child under the age of 14. and MUST STAY WITH THEM! NO EXCEPTIONS!

No children under 14 are allowed in the spa.

#### **HEALTH AND SAFETY**

Everyone must rinse down in the shower before entering the pool area. If you exit the door, you must shower again prior to entering the pool.

No running, horseplay, spitting in the pool or on the deck, dunking, throwing each other, playing chicken, or rough housing.

No backflips, spinning or twisting entry. Forward entry only.

No sitting, pulling, hanging on, or removing the safety rope.

No diving headfirst into the shallow end of the pool.

Non-swimmers must stay in the shallow end of the pool.

No foul language or obscene gestures.

No tampering with the rescue or safety equipment.

Do not leave your valuables unattended. Clearwood Community Association is not responsible for lost or stolen items.

No extended conversations with lifeguards.

Lap and Exercise sessions are limited to people using the pool for that purpose only. Excessive noise and/or splashing will not be tolerated. The pool deck is not open during this time.

The shallow end adjacent to the spa area is a "No Splash" zone.

Persons with open cuts, communicable diseases or who have or have had diarrhea or vomiting within the last 2 weeks are not permitted to use the pool.

Due to stringent Washington State health regulations, chemical treatment is required when the pool is fouled by vomit or human waste. This is an expensive treatment and significant inconvenience to the membership. Charges incurred for accidents of this nature will be billed to the property owner sponsoring the family member, renter or guest. Charges will include, at a minimum, cost of chemical, cost of required testing, staff wages, and certified pool operator (CPO) for the time the pool would normally be open, Member are reminded that they are responsible for the actions of their children, renters and guests while using any CCA facilities.

## ITEMS NOT ALLOWED IN THE POOL FACILITY INCLUDE BUT ARE NOT LIMITED TO

- Chewing Gum or Candy
- Vaping, Smoking or Tobacco use.
- Food or Drinks other than Water
- **Alcoholic Beverages** are prohibited. No person under the influence of alcohol or drugs are permitted to use the facility.
- Glass of Any Kind
- Animals other than documented service animals
- Non-Plastic Goggles or Masks
- No Beach Balls or Toys allowed.

#### **POOL WEAR**

Properly hemmed cut-offs are permitted- NO DENIM OR BLUE JEAN CUT-OFFS.
All swimmers must wear proper swim attire in the pool enclosure. Life jackets, arm bands, and small floats for babies, and float swimsuits are allowed.

**Items Not Allowed-** Street clothes or Street shoes, jean shorts, disposable diapers (Only approved simmer diapers are allowed. All diapers must be changed at the designated changing area and all diapers must have protective covering to avoid contamination. **NO EXCEPTIONS!**
