2025 POOL RULES & REGULATIONS

The following Rules and Regulations are for the protection and benefit of all to ensure safe and sanitary operations of the pool and facilities. Parents are required to caution their children to observe all rules and regulations and to obey the instructions of the lifeguards.

1. Lifeguards are on duty to ensure your safety. Please assist them by being a safe and courteous swimmer and following their instructions. Those not complying with the rules or who conduct themselves in any way dangerous to themselves or others ***may be removed from the pool at the lifeguard's discretion.***
2. All persons using the pool must have a valid virtual pool pass to gain admission. Everyone must check-in before accessing the pool and members' guests must sign in and always be accompanied by a pool member.
3. Members are responsible for all actions of their guests. The cost of property damage will be charged to the member.
4. Per Maryland state law, children under 12 years of age must be accompanied and supervised by a person 16 years or older. **Our Lifeguards' job is pool safety – Parents are responsible for their children's whereabouts and conduct. It is the parents' responsibility to ensure that their children understand and follow the rules.**
5. No child under the age of 6 is allowed in the big pool unless supervised (within arm's reach) by a person who is 16 or older.

6. Maryland State law reads that all persons must shower before entering the pool.
7. Only swimsuits are allowed in the pool (no cut-offs, etc.) Fabric threads & fibers can clog filters. Swimsuits must fully cover all private areas.
8. Do not enter the water if you are sick, have an open sore, rash, or any other irritation.
9. The last 15 minutes of each hour will be required rest for all swimmers under 16 years of age. They must exit the pool at this time when the whistle blows. During this time, an adult may accompany [only] one preschool or infant child in the pool for some special quiet time. Children over the age of 6 exiting the pool may not go into the baby pool at this time - The baby pool is for children 6 & under.
10. Running, pushing, spitting, profanity, rude behavior, rough play, and other objectionable personal conduct is prohibited. Please ask that your children show good manners and respect for the lifeguards, and for all adults at the pool.
11. Dive only where / when diving is permitted. One person is permitted on the diving board at a time. Diver must have hands in front when diving, and only one bounce on the diving board is permitted. **Flips are prohibited.** Diving from the side of the board or hanging from the board is prohibited. When diving from the board, the swimmer must swim directly under the rope or exit by using the ladder. Management reserves the right to restrict the use of the diving board. Diving / jumping into the well is prohibited when the board is closed, and chain is hung.
12. ALL Children wishing to use the pool must first demonstrate to a lifeguard their ability to swim a lap length and tread water, unless under direct supervision of an adult.

13. Swimmers in the water have right of way. Those entering the water must make certain that no one is in front of them.
14. Only flotation devices certified by the coast guard are allowed in the main pool, except as follows: children will be permitted to wear “water wings” or safety bubbles in the main pool if they are under the direct supervision (within arm’s reach) of a parent or of someone at least 16 years of age. This privilege is subject to suspension by the lifeguards if the use is such that it might present a hazard to other people in the pool. **(No blow-up rafts/chairs/balls or donuts)**
15. Fins, snorkels, and noodles may be used with permission from the supervisor. Playing any game, which involves diving down to the deep end of the well and touching the main drain, is prohibited.
16. Ball playing is strictly at the discretion of the lifeguards. Games should not “take over” the low area of the pool where small children play. Only soft foam uncovered nerf type balls are permitted – no “Splash Balls”. (None red in color, which is sometimes used by the lifeguards for drills)
17. Under no circumstances shall a child be left unattended in the wading pool area. Only children 6 and under are allowed to use the wading pool. No flotation devices larger than an inflatable swim ring will be permitted in the wading pool. Adults are responsible for supervising their children in the wading pool. Lifeguards are not posted in this area and are only for emergency services.
18. Disposable diapers are not allowed in pools. Babies must wear only “Little Swimmers” type, or cloth diapers and rubber pants. Disposable diapers can clog filters, and diaper leakage will cause long pool closings.
19. Maryland State Law requires that the pool be shut down for 16 hours due to excrement in the pool, and for a period to be determined by the pool operator for blood or vomit.

20. NO GLASS or portable grills allowed in the pool area during normal pool hours.
21. No chewing gum allowed in the pool area, and it is highly advised that hard candy not be brought into the pool area either. Food is permitted in the pool area but prohibited in the pool itself.
22. No alcoholic beverages may be brought into the pool area at any time. Persons who appear to be under the influence of alcohol or other controlled substances will not be permitted into the facility.
23. Smoking and vaping is prohibited. The Glade Towne Community Pool is a non-smoking facility.
24. Please Do Not Litter. All garbage must be put in trash receptacles in the pool area. Please help to keep the area clean.
25. Pool manager in accordance with Maryland State Law will decide on emergency closing due to weather. State law requires that the pool close for 1/2 hour after hearing thunder or seeing lightning.
26. The pool office and lifeguard designated table under the canopy is reserved for the exclusive use of on-duty High Sierra personnel only.
27. The telephone is for emergency use only.
28. There is parking available in the church parking lot. As a courtesy to residents who live on Chapel Place, please do not block driveways and mailboxes.
29. Pool parties will be scheduled through the Glade Towne office, not the pool manager. However, information may be obtained at both the pool and office.

31. Any arrogant or physical behavior compromising safety will result in an immediate 5-day suspension. If after the 5-day suspension there is further distracting behavior, the pool member may be suspended for the remainder of the season.
32. Pool privileges for anyone who is observed or charged with vandalizing the pool area, whether the pool is open or closed, will be suspended until an administrative hearing is held and innocence or guilt is determined. If they are judged guilty, pool privileges will be suspended for the remainder of the season or as determined by the Board of Directors. Pool Membership fees are non-refundable.
33. Management reserves the right for immediate / permanent dismissal for any act deemed of a criminal nature. If a pool member or guest refuses to leave or to stay away from the premises as instructed by management, their presence will be deemed as trespass, and the police will be called.
