#### **Goshen Valley Swimming Pool Rules & Regulations**

- 1. To be eligible for membership at the Goshen Valley Swimming Pool, you must be a resident who is in good standing with their Association. All payments on fees, fines assessments, etc. must be current. All unit owners and tenants must comply with the rules and regulations of their Association.
- 2. The Goshen Recreation Center, Inc., its management, pool assistants and lifeguards are responsible for reasonable safe and sanitary operations of the pool, bathrooms and grounds, general conduct of the residents and their guests and have complete authority to refuse to admit anyone because of health reasons, intoxication, misconduct or disregard of the rules and regulations.
- 3. All persons using the pool area do so at their own risk and sole responsibility. Goshen Valley Recreation Center Inc., its Management and each individual Association do not assume responsibility for any accident or injury concerning such use. Members and their guests, or any other person or persons covenants, agrees with Goshen Valley Recreation Center Inc., and/or their agent(s) for and in consideration of the use of the pool facility and other good and valuable consideration to make no claim against Goshen Valley Recreation Center Inc., and/or their agent(s) for or on account of any loss or damage of life, limb or property.
- 4. Members will receive access FOBS for only those persons living in Goshen Valley. Entrance to the pool is by presentation of FOB, pool pass and guest pass (if applicable). <u>NO ADMITTANCE WITHOUT</u>

  <u>THEM, NO EXCEPTION.</u> If a key FOB is lost, a new one will be issued for a fee of \$25.00 per FOB.
- 5. The Association is not responsible for loss or damage to personal property. The cost of any property damage will be charged to the responsible resident.
- 6. You <u>must</u> check in with the pool assistant on duty and present your pool pass; guests must be accompanied by a member, and they must be checked in by the pool assistant on duty upon entering the pool area. No one is permitted to enter without a valid membership or guest pass.
- 7. Please log onto <a href="https://swimmingpoolpasses.net/goshen-valley">https://swimmingpoolpasses.net/goshen-valley</a> to purchase guest passes. Guest passes are \$8.00 each.
- 8. No guest will be admitted unless accompanied by a member. Guests are subject to the same rules as members. Members assume all responsibility for the conduct of their guests.
- 9. Please shower at home before entering the pool area.

- 10.Persons with open sores, rashes or other infectious diseases will not be permitted to use the pool.
- 11. Spitting, spouting water and blowing one's nose in the water is not allowed.
- 12.At the discretion of the Lifeguard, a periodical, 15-miniute adult swim may be requested.
- 13.An adult must accompany children under the age of 14 while in the pool area. This applies to swimmers as well as non-swimmers. No children under 14 years of age will be permitted to enter the pool area unless accompanied by a parent or guardian.
- 14. Babysitters must be 18 years of age and will not be admitted to the pool unless sponsored by a member.
- 15. Children will be permitted to use the pool area if they can pass a swim test. You will be required to attest that your child has the capability to swim random testing may be requested by the Lifeguard.
- 16. The safety and comfort of all members is our greatest concern. Therefore, horseplay such as diving, running, pushing, wrestling, and ball playing will not be tolerated.
- 17. Radios and voices should be kept at a reasonable level in and outside of the pool area.
- 18. No diving and no cannonballs permitted.
- 19. Abusive, profane, or foul language will not be tolerated.
- 20.Alcoholic beverages are NOT PERMITTED AT ANY TIME in any of the pool or tennis court areas. Drunkenness and disorderly conduct will not be tolerated at any time and will result in the revoking of memberships without reimbursement.
- 21.Glass containers of any type are not permitted in the pool area.
- 22. Food and drink are not permitted in the pool. They are to be consumed in the seating area only.
- 23. No smoking or vaping in the pool or anywhere in the pool area.
- 24. Bicycles, skateboards, scooters, roller-skates, rollerblades, etc. are not permitted in the pool area.
- 25.Pets of any type are not permitted in the pool area. With the exception of required guide dogs.
- 26.Balls, floats, surfboards, inflatable mats, toys, etc. are not permitted in the pool area without the consent and supervision of the Lifeguard on duty. No oversized floats permitted.
- 27. Children will be permitted to use flotation devices only if their operation does not disturb other members. Only US Coastguard approved flotation devices will be allowed.
- 28. There will be no pool parties at any time.

- 29. Swimmers must wear appropriate swimming attire. Only white t-shirts will be permitted over swim attire. Street clothes, cut-off jeans, thong bathing suits, etc. will not be permitted.
- 30. The Lifeguard is <u>not permitted</u> to baby sit for any children during pool hours.
- 31. The pool may close at anytime due to mechanical breakdown or inclement weather.
  - Swimming in the pool when the Lifeguard is NOT on duty is PROHIBITED! There are NO EXCEPTIONS to this rule! Anyone caught inside the pool area after hours will incur a fine of \$300.00 and lose pool privileges for the season.
- 32. The Lifeguard is an employee of Neptune Pool Management and represents Goshen Valley Recreation Center, Inc. (a non-profit corp.). All rules and regulations that are handed down by the Board of Directors are strictly enforced by the pool assistant on duty and/or the lifeguard and all decisions of the pool assistant and/or lifeguard are final.
- 33. The pool assistant and/or lifeguard are responsible for the strict enforcement of the rules and regulations. Any person may be barred from the pool area at the discretion of the pool assistant and/or lifeguard for repeated violations of the rules and regulations, or for any other reason which in his/her judgement constitutes a hazard to others or to the Association and Management. Written statements will be filed with Neptune Pool Management within 24 hours if such action is taken.

## Verbal Enforce:

1<sup>st</sup> Offense – A Warning 2<sup>nd</sup> Offense – Benching 3<sup>rd</sup> Offense – Removal from the Pool Area.

# <u>Maximum Enforcement of Violations after 3<sup>rd</sup> Offense of Rules and Regulations:</u>

- 1. Suspension from pool area for one week
- 2. Suspension from pool area for two weeks
- 3. Suspension from pool area for the remainder of the season and a \$100.00 fine.

<u>Drunkenness</u> and/or disorderly conduct will not be tolerated. Such action will result in the immediate removal from the pool area and revoking of membership.

## Baby Wading Pool

- 1. The lifeguard is NOT RESPONSIBLE FOR THE BABY WADING POOL. Children using the baby pool must be under the supervision of a parent or guardian at all times.
- 2. Wading pool is for the use of children under the age of 5 and their parents and guardian.
- 3. No running, throwing of balls, toys, etc. in the wading pool.
- 4. Diapers with plastic pants or pool diapers must be worn at all times by infants and children who are not potty trained. A clean diaper must be worn before entering the pool.
- 5. All pool general rules and regulations apply.

The Lifeguard, Management and Members of the Recreation Center Inc., Board of Directors can levy the penalties and fines.
