Mail a paper *Application*. There is a \$10.00 processing fee for non-residents to mail a paper application.

Please list all household Association members who will be using the pool and their relationship to the property owner. \*Restricted to individuals who reside in the household as their primary residence. Proof of residency for non-property owners may be required. (Driver's license, state issued ID, etc.) Note: All children under the age of 4 must wear an approved swim diaper. All family members must reside at the same address.

#### Please list all members who will be using the pool including self.

Except for Patron 1, do not use the term "self" as an indication of relationship. (i.e.: spouse, son, daughter, etc.)

Should a resident move out of Kennington, they are responsible for returning their pool passes to the Management Company. If passes are not returned, there will be a \$35 charge assessed.
