Option #2: Mail a paper *Application*. There is a \$10.00 application fee to mail a paper application.

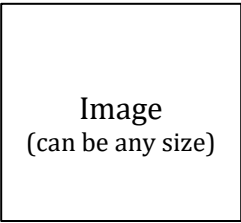
