How do I receive my pool passes?

1. Apply online at <https://www.swimmingpoolpasses.net/MarinersPoint/>
or
1. Submit the pool Application below. Requires a picture and date of birth for every applicant. The date of birth will be listed on the pool pass so the Pool Guard can validate.
2. Attach a colored forward facing picture of **each member of your household**.

Passes will be mailed to your home along with a complimentary guest passes according to the community's rules and regulations.
