

Parental Teen Consent and Waiver of Liability

Please read before signing this form:

Parent(s)/Legal Guardian(s) are solely responsible for determining if their minor child(ren) is physically fit and/or adequately skilled to use the Association's pool and facilities.

Please understand and recognize that lifeguards are not responsible for providing supervision or assessing the swimming skills of your minor child(ren); rather, lifeguards are responsible for enforcing safety rules and responding to emergencies. Parents/legal guardians of minor children are solely responsible for supervision of any and all activities in or around the pool.

Swimming and other aquatic activities are inherently risky and there is always a risk of serious injury, including but not limited to drowning and head/brain injury. The very nature of swimming and aquatic activities are hazardous and risky, including but not limited to fatigue and overexertion, poor swimming skills, failing to avoid dangerous areas, failing to follow rules and regulations, failure of lifeguards to locate victims and/or delay in emergency response time, striking the bottom or side of the pool, inadequate supervision or instruction, slip and falls on the deck, chemical exposure, and all other circumstances inherent to aquatic activities. In this regard, it must be recognized that it is impossible for Newberry Towne Association, Inc. to guarantee your minor child(ren)'s safety.

Please read this form carefully and be aware that in consideration for the Association's allowing your minor child(ren) age 14-17 to use the Association's pool without supervision, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages, or loss which you or your minor child(ren) might sustain as a result of the child(ren)'s use of the Association's pool and facilities.

I recognize and acknowledge that there are certain inherent risks of physical injury to users of aquatic facilities, and I voluntarily agree to assume the full risk of any injuries, damages or loss, regardless of severity that my minor child(ren) may sustain as a result of the child(ren)'s unsupervised use of the Association's pool and facilities. I further recognize and agree that lifeguards and other aquatic staff are not responsible for supervising my minor child(ren).

I agree to indemnify and hold harmless Newberry Towne Association, Inc., including its directors, officers, agents, volunteers, and employees (hereinafter collectively referred to as "Pool and Personnel") and to waive and relinquish all claims I, or my minor child(ren) may have (or accrue to me or my child(ren)) in connection with their use of Newberry Towne Association, Inc.'s pool/facilities or their presence on the premises. I do hereby fully release and forever discharge the Pool and Personnel from any and all claims for injuries, death, damages, or loss that my minor child(ren) or I may have or which may accrue to me or my minor child(ren) and arising out of, connected with, or in any way associated with use of Newberry Towne Association, Inc.'s pool and facilities or presence on the premises. I do hereby release on my behalf and on behalf of myself, my spouse, my child(ren), and our respective heirs, assigns and personal representatives, all of our rights to sue Newberry Towne Association, Inc. and its directors, officers, employees, agents, and assigns (hereinafter referred to as "released parties") for personal injuries, property damages, or wrongful death and lost consortium that may result from my child(ren)'s unsupervised use of Newberry Towne Association, Inc.'s pool and facilities, including but not limited to the inherent risk associated with swimming or as a result of negligence of released parties or any other party.
