Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. The virus that causes **COVID-19 is highly contagious**. It spreads mainly from person to person, typically through respiratory droplets from coughing, sneezing, or talking. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Tenakill Swim Club (“the Club”) has put in place preventative measures to reduce the spread of COVID-19 during the **2021** season; however, the Club **cannot guarantee** that you or your child(ren) will not become infected with COVID-19. Further, **attending the Club could increase** your risk and your child’s/children’s risk of contracting COVID-19.

By signing this agreement, we acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that our child(ren) and we may be exposed to or infected by COVID-19 by attending the Club and that such exposure or infection may result in personal injury, illness, permanent disability, and death. We understand that the risk of becoming exposed to or infected by COVID-19 at the Club may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club employees, volunteers, and other Club members.

We voluntarily agree to assume all of the risks and accept sole responsibility for any injury to our child(ren) or ourselves (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense of any kind, that we or our child(ren) may experience or incur in connection with our child(ren)’s attendance at the Club or participation in Club activities (“Claims”). On behalf of ourselves and our children, we hereby release, covenant not to sue, discharge, and hold harmless the Club, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. We understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Club, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Club activity. We further affirm that we will act in good faith and keep ourselves or any family members home from the Club if we are experiencing any illness symptoms.

Tenakill Swim Club follows all mandated guidelines to place safety measures at the Club. We reserve the right to change or modify protocols at our discretion to ensure our members and staff are safe while still providing the best experience at Tenakill Swim Club during COVID-19. We understand that failure to follow Tenakill’s rules & regulations, including those outlined in the written compliance plans, may result in removal from the pool and/or pool grounds.
