- 5. I understand that the Pool may be closed without notice. In addition to any other rights that the HOA may have due to my failure to comply with the terms of this Release, I agree that my ability to Use the Pool may be suspended immediately and/or revoked.

I, for myself, and on behalf of my minor child (if applicable), my heirs, successors, representatives, assigns, and anyone else who might have a claim by reason of my injury, illness, or death or damage or loss to property due to entering or using the Pool, hereby knowingly, voluntarily, and intentionally release, indemnify and hold harmless the HOA, and its agents, contractors, employees, directors, officers, and volunteers from any and all claims, liability, costs, expenses, injuries, causes of action, including negligence, while using, entering, exiting, being present in or in proximity to the Pool. Notwithstanding the foregoing, I understand and agree that no provision of this Release shall be construed to constitute my waiver of any claims arising out of gross negligence or willful misconduct.
