

Woodbridge Center Swim Club Rules and Regulations

The Woodbridge Center Pool is for the use of paid members and their immediate family currently residing in Woodbridge Center Homeowners Association and their guests possessing daily or seasonal passes. The following rules and regulations apply to all residents and guests. Parents will be held responsible for their children's behavior and their children's observance of all rules and regulations. A tenant who rents a property in Woodbridge Center may be considered a paid member if the homeowner has signed over all privileges of this facility to the said tenant(s).

- a. Owners are responsible for their guests.
- b. Current year pool passes with pictures affixed must be shown for admittance. NO EXCEPTIONS.
- c. All persons using the pool facility do so at their own risk and sole responsibility.
- d. The cost of any property damage will be charged to the responsible resident.
- e. Neither Woodbridge Center Homeowners Association, Inc. nor the pool Management Company or Association Manager assume responsibility for any accident, injury, loss or damage to the persons or their property in connection with such use. The residents and their immediate family, and any guest, agree to save and hold harmless Woodbridge Center Homeowners Association, Pool Management Company or Association Manager the damage sustained.
- f. Lifeguards are on duty to enforce these Rules & Regulations and to respond to emergencies but parent/ guardian is ultimately responsible for the safety of their child and guests. Lifeguard's have full authority to temporarily suspend all pool privileges and eject any individual that is in violation of the Rules & Regulations of this facility
- g. The Board of Directors and association manager has the right to suspend and/or revoke pool privileges of anyone not abiding by the Rules & Regulations of the Woodbridge Center Swimming Club at any time.
- h. All guests of the Woodbridge Center Swim Club must be accompanied by resident (over 18 years old) at all times and adhere to the Woodbridge Center Rules & Regulations.
- i. Parent/Guardian must closely watch children and accompany a non-swimmer in the water at all times. Parent/Guardian is solely responsible for assessing and knowing their child's swimming ability.
- j. No one shall be allowed into the pool area unless qualified lifeguards provided are on duty.
- k. Running, pushing, wrestling, diving, horseplay, profane or obscene conduct causing undue disturbance in or around the pool will not be tolerated. Spouting of water & similar unhygienic acts are not permitted in pool area.
- l. No alcoholic beverages or illegal substances allowed. No one under the influence of intoxicants or drugs will be permitted in the pool areas.
- m. All children under the age of thirteen (13) years old must be accompanied by an adult 18 years or older.
- n. No one over the age of six (6) years old are allowed in the wading pool. All children in the wading pool must have an adult supervising them in attendance and at all times.
- o. All radios and music must be kept at a low volume.

- p. No disposable diapers are allowed in either of the pools. If the child is not toilet trained they must have tight fitting rubber pants or "swim diapers" on.
- q. All beverages or food brought must be on/in paper or plastic containers.
- r. No glass containers are allowed in the pool area.
- s. No chewing gum.
- t. Strollers and wheelchairs are permitted on the pool deck area but must be behind the blue lines.
- u. No pets are allowed in the pool area.
- v. No smoking, permitted in the pool area and must be at least 20 feet from entrance gate.
- w. Swimsuits are required at all times; no cut-offs are to be worn in the pool at any time.
- x. No admission to persons having an infection, disease, sore, and/or inflamed eyes, colds, nasal or ear discharge, or open sores of any kind.
- y. Anyone swimming is required to shower before entering pool.
- z. Flotation mats, rafts, inner tubes and water wings are not permitted in the pool area at any time. Lifeguards will regulate toys and games according to pool occupancy. Only life vest approved by US Coast Guard is to be used. If vest is used, parent/guardian must accompany the child in water at all times.
- aa. The pool may close at any time due to bad weather, breakdown, or other operational difficulties, at the discretion of the Woodbridge Center Homeowners Association.
- bb. The pool manager will use his/her discretion on any unspecified matter. If necessary, clarification will be sought from the Woodbridge Center Homeowners Association Board of Directors.
- cc. All personal injuries, however slight, must be reported to the lifeguard on duty.
- dd. No person convicted of a sex crime against a child is permitted in the pool area.
